NOTICE OF PUBLIC HEARING REQUIREMENTS

I. Certain types of development applications require PUBLIC NOTICE. These Include:

1. PRELIMINARY SITE PLAN APPROVAL
2. REQUEST FOR VARIANCE APPROVAL
3. CONDITIONAL USE APPROVAL
4. DIRECT THE ISSUANCE OF A PERMIT FOR LOT LACKING STREET FRONTAGE OR FOR PROPOSED STRUCTURES TO BE LOCATED IN THE BED OF A MAPPED STREET
5. PRELIMINARY SUBDIVISION APPROVAL
6. ANY PROPOSAL LOCATED IN A FLOOD PLAIN
7. APPEALS
8. A REQUEST FOR INTERPRETATION OF ANY ZONING PROVISION OF THIS CHAPTER
9. WAIVER OF SUBDIVISION/SITE PLAN OR ANY OTHER DESIGN STANDARDS
