Be It Ordained by the Council of the Township of Hamilton, in the County of Mercer and State of New Jersey, that the *Code of the Township of Hamilton, New Jersey, Chapter 215, Fees, § 215-8, Department of Public Safety, and § 215-9, Department of Community and Economic Development*, as amended and supplemented, be further amended and supplemented as follows:

Business, Mercantile, Commercial, Factory, Industrial, Storage, Warehousing or Utilities
