Bid documents may be obtained during office hours (8:30 A.M. to 4:30 P.M.) in the Division of Budget & Purchasing, 2090 Greenwood Avenue, Hamilton, NJ 08609. **Due to the Coronavirus, all bidders must call (609)890-3648 or (609)890-3528 prior to picking up a bid. A Purchasing Department staff member will greet you at the front main entrance door where the payment will be received, a receipt will be given and a bid package will be provided.**

Bids shall be rejected if not submitted within time, date and at place designated and if not accompanied by a certified check, cashier's check or bid bond as specified in the bid document.

All bids/RFP's must be stamped by 10:00am to be valid, any bid stamped in after 10:00am will not be accepted.

Due to Covid-19, if you would like to attend the public opening, you must call (609)890-3648 or (609)890-3528 to register your company to allow entrance into the Municipal Building.

The successful bidder shall be required to comply with the provisions of the New Jersey Prevailing Wage Act, Chapter 150 of the Laws of 1963, effective January 1, 1964.

All contractors are required to comply with the requirements of N.J.S.A. 52:32-44 (Business Registration), N.J.S.A. 10:5-31 et seq. and N.J.A.C. 17:27 et seq. (Contract Compliance and Equal Employment Opportunities in Public Contracts). Submission by corporations, partnerships and limited liability companies shall include a completed Disclosure of Ownership form (N.J.S.A. 52:25-24.2). Submissions shall also include a completed Non-Collusion Affidavit. All requirements of the State of New Jersey Worker Health and Safety Act (N.J.A.C. 12:110 et seq.) as amended and the United States Occupational Safety and Health Act (OSHA) (29 CFR 1910), as amended with regard to worker and jobsite safety.
