NOTICE OF VIRTUAL PUBLIC HEARING**

NOTICE is hereby given that on the 11th day of March, 2021, at 6:00 p.m., the Hamilton Township Planning Board (the “Board”) will hold a public hearing, via electronic means as described below:

To observe and to participate: Prior to the meeting you should download the Zoom meeting application to the electronic device you will use to access the meeting. Just prior to or at the time of the meeting, you should open the Zoom application, and input the meeting Link, Meeting ID, and Access Code to join the meeting. You will be prompted on audio and video access choices. You may wish to familiarize yourself with the operation of the Zoom platform prior to the time of the meeting, particularly with the process of “raising your hand” to be recognized during public participation.
